Pursuant to notice by the Interim-Executive Director, the Regular Meeting of the Retirement Board of the Massachusetts Bay Transportation Authority Retirement Fund was held on Friday, July 16, 2021, at 9:32 AM, at One Washington Mall, 4th Floor, Boston, MA 02108.

The Members present by video conference were James, Evers, James Bradley, Craig Hughes and Betsy Taylor; Alternate Members were, John Clancy, Patrick Hogan, Gerald Kelley, Timothy Long and Mary Ann O’Hara.

Also present were John P. Barry, Interim-Executive Director; Jacquelyn Carey, Acting Recording Secretary; and staff. Julian Regan and Pamela Dubuc of Segal Marco Advisors were also present.

Interim-Chairperson James Evers presided.

He reported that for the month of June, the Fund had a total of \$13,207,174 in deposits and \$19,062,736 in withdrawals for a net-negative of \$5,855,563. He added that the market value at the end of June 2021 was \$1,873,666,841. The Executive Director reviewed the overall performance of each of the Fund's asset classes in comparison to their respective benchmark.

VOTED:- THAT the Retirement Board of the MBTA Retirement Fund move into Closed Session.
